# REPORT ON THE REALIZATION OF STRATEGIC GOALS AND ACTION PLAN - NALED 2019

\* Activities realized before the planned period

Out of 228 activities defined for the period 2019-2021, there were 180 activities planned for 2019 (among these are also some repetitive activities which are being implemented continuously, year by year), which altogether makes 79% of all activities. Out of that number, 95% of activities were realized in 2019 (73% of activities completely, 22% partially realized), while 5% of activities planned for 2019 were not realized. On the other hand, 6% of activities planned for the next period (2020, 2021) were realized in advance.

# PROGRAM GOAL 1 - IMPROVEMENT OF REGULATORY AND INSTITUTIONAL FRAMEWORK FOR DOING BUSINESS

Out of all activities defined for implementation in 2019 within the program goal 1 - Improving the regulatory and institutional framework for business, 95% of activities has been implemented (74% fully and 21% partially), while 5% of planned activities were not implemented. Additionally, 5% of activities planned for the period 2020-2021 were realized in advance, during 2019.

#### Additional activities in the field of property and planning and construction

- An interdepartmental working group has been formed in order to improve the procedure of property registration in the cadastre and harmonization of regulations related to this procedure. A working group with all relevant members gathered in November 2019 in Vrdnik to explain the announced changes to the Law on the Procedure of Property Registration in the Cadastre. NALED was actively involved in the formulation of the articles that were the subject of changes (i.e. the improvement of the delivery procedure, clarification of the entry of registration in the cadastre and registration of rights in the cadastre without a special decision consolidation and legalization).
- In addition to the planned trainings for Republic Geodetic Authority officials, trainings were held for representatives of the local tax administrations, republic tax administration, public notaries, chambers of public executors, lawyers and courts, in connection with the Law on the Procedure of Property Registration in the cadastre and amendments to the Law on Property Taxes. In addition to the 500 planned representatives of the competent authorities, over 1500 representatives of the mentioned institutions were trained.
- In addition to the Cadastre Registration Guide, a Tax Guide and Instructions for Courts have been prepared.
- As of January 1, tax returns have been abolished and tax liabilities for the registration of real estate rights are determined by a public notary
- Four round tables were organized with judges, ie with officials who are directly involved in the delivery of documents through the e-Counter.

# STRATEGIC GOAL P1 SC7 \* NEW \*: IMPROVED CONDITIONS FOR ENVIRONMENTAL PROTECTION

Detailed elaboration of this strategic goal through results, indicators and activities is envisaged within the periodic revision of the Strategic Plan for 2020/2021.

At the General Assembly of NALED in April 2019, the members launched an initiative to include the topic of environmental protection among the strategic priorities of the association, which was adopted. During 2019, several activities were implemented to establish internal capacities through the formation of an expert team - the Environmental Protection Unit within the Executive Office, and the establishment of a new alliance in NALED that deals with this topic with the support of as many as 35 founding members. NALED is involved in four working groups for amending regulations in the field of environmental protection, and drafting a Decree on the criteria for calculating the fee for environmental protection and improvement. The first project in this area was implemented with the support of GIZ "Towards better management of electrical and electronic waste", within which the NRIZ and the software for financial instruments of the Ministry of Foreign Affairs were improved. Four new project proposals in this area have been prepared and approved, with financial support from GIZ and UNDP. Part of the activities within the project "Responsible food waste management" was realized - an analysis of the food waste management system was prepared and a proposal for the Rulebook.

# PROGRAM GOAL 2 - STRENGHTENING THE CAPACITIES AND RESPONSIBILITY OF PUBLIC ADMINISTRATION

When it comes to Program goal 2 - Strengthening the capacity and responsibility of public administration, of all activities defined for implementation in 2019, and activities that are repeated from year by year, 91% of activities have been realized (69% fully implemented, 22% partially), while 9% of planned activities have not yet been implemented in 2019.
